Please kindly find below Akfen Holding's announcement regarding its share purchases within the "Share Buyback Program":

Within the "Share Buyback Program" approved at the Extraordinary General Assembly on 15 January 2015, our Company repurchased a total of 14,520 Akfen Holding shares on 16 June 2015. Following this transaction the total of share purchases within the frame of the 'Share Buyback Program' so far have reached 6,066,783 shares. The transaction details are shown in the table below.

Our Company holds 7,989,806 Akfen Holding shares, acquired within the previous share buyback program. Thus, in total share purchases have reached 14,056,589 shares, making up 5.37% of the Company's paid-in capital.
