Please kindly find below Akfen Holding's announcement regarding its share purchases within the "Share Buyback Program":

On 6 June 2013, Our Company repurchased a total of 32,923 Akfen Holding shares. Following this transaction the total of share purchases within the frame of the 'Share Buyback Program' so far has reached 3,423,839 shares, which represents 1.177% of the Company's paid-in capital. The transaction details are shown in the table below.

Meanwhile, during the period 27 November-3 December 2012, Akfen Insaat has purchased a total of 4,509,654 Akfen Holding shares, and thus in total share purchases has reached 7,933,493 shares. When Akfen Insaat's previous stake of 2.75% is also included, the Company and its subsidiaries' stakes in total rose to 5.47% of the Company's paid-in capital.
